The fee is charged monthly on the 5th day in case of failure to comply with the conditions for free use of the card.

² Up to KZT 500,000 (equivalent in another currency) per month – at the Bank's ATMs, in the BCC.KZ system (single limit)

³ Unless otherwise provided by the agreement between the Bank and the legal entity
